## Sani-Baby, Sani-Man & Sani-Child Instruction for Use





## Thank you for buying an American made product.

The purpose of this instructional is to familiarize the user with the function, care and maintenance of the Simulaids' Sani-Baby training manikin. It is not meant to provide instructions in CPR or other emergency life procedures. Please read it thoroughly. All Simulaids manikins are designed and manufactured to exacting standards and will provide years of effective and trouble-free use when the simple steps of care and maintenance are regularly performed.

**Note:** The manikin you have just purchased is a member of Simulaids' Sani-Man line. These manikins serve many individuals during a training session. In order to eliminate cross-contamination, or the possibility of cross-contamination, these manikins are designed with a "single use airway." That means that only one person uses the plastic bag airway system.

When the individual completes his/her airway inflations, the bag is to be removed and the next student will place his/her airway in the manikin. The airway can be retained by an individual for further use during that training session, but the airway should be discarded at the end of that session. This is the only recommended procedure for eliminating cross-contamination.

## **Airway Removal**

- 1. Remove chest overlay from shoulders and peel down.
- 2. Remove the face shield bag by pulling it out of the mouth.

## **Airway Installation**

1. Fold opened end of face shield bag as shown below. Tilt head back and place folded end up through the mouth.

2. With head tilted back lay the lung flat against the chest and pull the overlay back up into place and snap.

3. Form the face shield to cover face from nose to chin.



**WARRANTY:** Simulaids warrants this product to be free from any defect in materials and/or workmanship for a period of three years from the date of purchase, as evidenced by the date of invoice when the product was shipped to the end user. This warranty expressly does not cover abuse, accidental or purposeful damage, or any form of modification to the product. Any product considered for warranty work must be identified by serial number and invoice number from the agency through whom the product was purchased. Without this information the product will not receive a return authorization number as required.
